CHAIRMAN'S REPORT 2024/25 - SUMMARY NOTES

Introduction

Frustrating Year

- Felt the impact of Somerset Council reorganisations
- Local Authority doing less Parish Councils expected to do more
- Reduction in Parish Council powers in some areas

Local Community Networks

- Although we have attended all full meetings and they are better structured, they generally continue to be poorly attended (typically, no more than 8 out of the 23 member parishes attending meetings). Their effectiveness has been questioned but a clear purpose and value is still to materialise
- A new more locally relevant LCN was tabled (in conjunction with Woolavington) told such changes would not be considered for another year at least
- Somerset Council have put in additional support and appointed a new more proactive LCN coordinator (Emmaline Kay) resulting in meetings being more structured than the previous year
- Participated as part of the Highways Working Group allowing access to data not otherwise available (relating to gullies)
- Next meeting full LCN Meeting Cossington, April 23rd

Village Maintenance items

- Usual reporting of fly tipping, road defects, monitoring of dog fouling
- Somerset Council investigated suspected sewage in ditches in Brent Road– no evidence but will be kept under review
- Flood risk purchase of two long-handed rakes to assist in clearing blocked access to main watercourse but not in time to prevent overnight water build-up due to an unexpected heavy overnight downpour at the end of October
- The new Highways standards for "on-urgent" repairs and gulley clearance have come into force access to gulley data via Kier (through the LCN) and subsequent discussions with Highways have hopefully resulted in flood risk areas of Cossington being treated more favourably than originally proposed.
- The school clock has been restored to operational status

Finance

- Conducted through normal Procedures, Governance and External Audit
- Exceptional rise in precept.
 - Only agreed a after thorough assessment of impact on residents minimal (less than £2 per month for band D)
 - Purpose external highways contingency considering the new Highways standards, urgent major Playing Field repairs and maintenance

• Change in suppliers (e.g. Playing Field grass cutting and bin emptying) due to Somerset Council service changes

Planning

- Year started with finding out indirectly that Parish Council powers in planning matters had been reduced with applications for which an objection being lodged now being able to be approved without going to the Development Committee.
- 11 planning applications including one to be discussed in the meeting that follows) and one in Woolavington which had a greater impact on Cossington residents.
- Frustrations with planning enforcement a particular planning violation first reported a year ago had received no substantial response despite several follow-ups (raised with MP Ashley Fox on a recent visit)
- Attended two preliminary sessions for the launch of the new Somerset Local Plan (adoption scheduled for 2028)

Playing Field

- See Saw replacement at start of year
- Urgent repairs necessary to car park fence and path and maintenance to shelter and goalposts
- Continued and Increased use by Archery Group, "Home" for Sustrans Rangers
- Concern from encroachment from neighbouring sites to the west but at least the boundary has now been fully fenced
- Community Wood tree and bale planting, planning a wildflower meadow, a number of community days had taken place
- Future use for Vets' dog show and possible rounders group hire

Cossington in Bloom

• 2024 followed the same format as the 2023 successful event with addition CIB Extra categories. However, this year the attendance at the prizegiving event was disappointing.

105. Planning Applications

The following new planning application was considered 22/25/00001 – Conversion of stable building into two holiday lets and erection of replacement stable building with menage, The Pollards, Middle Road – Mr & Mrs J. Hadley – raise no objection.

The MP and his Chief of Staff had recently visited the playing field, accompanied by the Chairman and Vice-Chairman, to review the unauthorised increase of mobile homes on adjoining land. A suspected planning violation had been reported a year ago with no material response from Somerset Council despite several reminders. It was agreed that, considering the above and the MP's advice, to attempt to escalate the matter through Somerset Council's formal complaint procedure.
